Free-look Cancellation

The policy holder has a period of 15 days from the date of receipt of the policy document to review the terms and conditions of the policy and where the insured disagrees to any of those terms or conditions, he has the option to return the policy stating the reasons for his objection, when he shall be entitled to a refund of the premium paid, subject only to a deduction of a proportionate risk premium for the period on cover and the expenses incurred by the Company on medical examination, if any, and stamp duty charges.

A request received by the Company for free look cancellation of the policy shall be processed and premium shall be refunded within 15 days of receipt of the request.

For any delay, the Company shall pay penal interest at a rate, which is 2% above bank rate from the date of request or last necessary document if any whichever is later, from the insured/claimant as stated above

PART B: Definitions

- **B1.** Age: Age of Life assured as on last birthday (in completed years)
- **B2.** Appointee: Appointee is the person to whom the proceeds/benefits secured under the Policy are payable if the benefit becomes payable to the nominee and nominee is minor as on the date of claim payment.
- **B3.** Annualised premium: shall be the premium payable in a policy year chosen by the policy holder excluding the underwriting extra premium, rider premium, and loading for modal premiums, if any. Premiums are exclusive of service tax.
- **B4.** Authority: means the Insurance Regulatory and Development Authority of India established under the provisions of section 3 of the Insurance Regulatory and development Authority Act, 1999 (41 of 1999)
- **B5.** Assignment: Assignment is the process of transferring the rights and benefits to an "Assignee". Assignment should be in accordance with the provisions of Section 38 of Insurance Act, 1938, as amended from time to time
- **B6.** Assignee: Assignee is the person to whom the rights and benefits are transferred by virtue of an Assignment.
- **B7.** Authority: means the Insurance Regulatory and Development Authority of India established under the provisions of section 3 of the Insurance Regulatory and development Authority Act, 1999 (41 of 1999)
- **B8. Bank rate**: means "Bank rate fixed by the Reserve Bank of India (RBI) at the beginning of the financial year in which claim has fallen due"
- **B9.** Beneficiary: Beneficiary means the person who is entitled to receive benefits under this

Policy. The Beneficiary may be proposer or Life Assured or his Assignee or Nominees or proved Executors or Administrators or other Legal Representatives as the case may be.

- **B10.** Complaint/Grievance: means written expression (includes communication in the form of electronic mail or other electronic scripts) of dissatisfaction by a complainant with insurer, distribution channels, intermediaries, insurance intermediaries or other regulated entities about an action or lack of action about the standard of service or deficiency of service of such insurer, distribution channels, intermediaries, insurance intermediaries or other regulated entities
- **B11. Complainant:** means a policyholder or prospect or any beneficiary of an insurance policy who has filed a complaint or grievance against an insurer or a distribution channel
- **B12.** Cover: means an insurance contract either in the form of a policy or a cover note or a Certificate of insurance or any other form as approved by the Authority to evidence the existence of an insurance contract
- **B13.** Date of commencement of risk: The date from which the insurance cover under the policy starts.
- **B14.** Date of commencement of the policy: Date on which the policy commences.
- **B15.** Date of inception: Date of issuance of the policy or date of effecting the policy.
- **B16.** Date of Maturity: Date of maturity means the date specified in the Schedule on which the Maturity Benefit shall become payable to the policyholder
- **B17. Date of vesting:** (applicable only to minor life assured) is the policy anniversary date immediately following completion of 18 years of age of life assured. The Life Assured becomes entitled to the policy benefits from date of vesting as specified in Condition 3 of Part C of this Policy Document



- **B18. Death Benefit:** Shall mean benefit agreed at the inception of the contract, which is payable on death as specified in the policy document.
- **B19. Discharge Form:** Discharge form is the form to be filled by policyholder / claimant to claim the maturity / surrender / death benefit under the policy.
- **B20. Distribution channels:** means persons and entities authorized by the Authority to involve in sale and service of insurance products
- **B21. Due date:** Due Date means a fixed date on which the policy premium is due and payable by the policyholder
- **B22. Endorsement:** Endorsement means conditions attached / affixed to this Policy incorporating any amendments or modifications agreed to or issued by the Company
- **B23.** Free-look: Free Look Period is the stipulated period from the date of receipt of the Policy Document by the Policyholder to review the terms and conditions of this policy and where the Policyholder disagrees to any of those terms and conditions, he / she has the option to return this policy as detailed in Condition five of Part D
- **B24.** Grace period: The time granted by the insurer from the due date for the payment of premium without any penalty/late fee during which time the policy is considered to be in force with the risk cover without any interruption as per the terms of the policy
- **B25.** In-force policy: In-force policy means a policy in which all the due premiums have been paid and the premiums are not outstanding.
- **B26. IRDAI**: Insurance Regulatory and Development Authority of India.
- **B27.** Lapse: Lapse is the status of the Policy when due premium is not paid within the grace period.
- **B28.** Life Assured: The person on whose life death risk is covered.
- **B29. Limited Premium Payment Policy**: Limited premium payment policy is the policy where the

premium payment period is limited compared to the policy term and are paid at regular intervals like yearly, half yearly etc.

- **B30.** Loan: Loan is the interest bearing amount granted by the Company against the surrender value payable to the policyholder.
- **B31.** Maturity Benefit: means the benefit payable on maturity as specified in the policy document.
- **B32.** Minor: Minor is a person who has not completed 18 years of age.
- **B33. Nomination:** Nomination is the process of nominating aperson who is named as "Nominee" in the proposal form or subsequently included / changed by an endorsement. Nomination should be in accordance with provisions of Section 39 of the Insurance Act, 1938 as amended from time to time.
- **B34.** Nominee: Nominee is the person/persons appointed by the life assured to receive the death benefit herein upon his/her death.
- **B35.** Paid-up: Paid up is the status of the Policy, if the premiums are paid for at least 2 full years and subsequent due premium/s have not been paid.
- **B36.** Policy/Policy document: Policy/Policy Document means this document along with endorsements, if any, issued by the Company which is a legal contract between the Policyholder and the Company
- **B37.** Policyholder: Person who has proposed to purchase the policy and pays the premium under the policy.
- **B38.** Policy Schedule: Document featuring the main details and benefits of the policy.
- **B39. Premium:** Premium is the contractual amount payable by the Policyholder at specified times periodically as mentioned in the schedule of this Policy Document to secure the benefits under the policy. The premium payable will be "Total Instalment Premium". The term 'Premium' used anywhere in this Policy Document does not include any taxes which is payable separately.



- **B40.** Premium paying term: Premium payment term means the period, in years, during which premium is payable.
- **B41. Proposal form** means a form to be filled in by the prospect in written or electronic or any other format as approved by the Authority, for furnishing all material information as required by the insurer in respect of a risk, in order to enable the insurer to take informed decision in the context of underwriting the risk, and in the event of acceptance of the risk, to determine the rates, advantages, terms and conditions of the cover to be granted.
- **B42. Proposer**: Person proposing insurance on own life or on the life of another person.
- **B43. Prospect**: means any person who is a potential customer of an insurance and likely to enter into an insurance contract either directly with the insurer or through a distribution channel.
- **B44. Prospectus**: means a document either in physical or electronic or any other format issued by the insurer to sell or promote the insurance products
- **B45.** Revival of a policy: Revival of a lapse/paid up policy which was discontinued due to the non-payment of premium, means restoration of the policy by the insurer as per underwriting decision, upon the receipt of all the premium due and other charges/late fee, if any, as per the terms and conditions of the policy, upon being satisfied as to the continued insurability of the insured on the basis of the information, documents and reports furnished by the policyholder, in accordance with the then existing underwriting policy approved by the company's Board.
- **B46. Revival Period:** Revival Period is the period of five consecutive years from the date of , first unpaid premium, during which period the policyholder is entitled to revive the policy which was discontinued due to the non-payment of premium.

- **B47.** Rider: Rider is an add-on benefit in addition to basic benefits as specified under this Policy.
- **B48.** Simple Reversionary Bonus: Simple Reversionary Bonus is the surplus/profit added by the Company to 'with-profits' policies. It is declared per thousand Basic Sum Assured at the end of each financial year based on the Corporation's experience.
- **B49.** Sum Assured: Absolute amount chosen by the policyholder at the time of proposal in accordance with the terms & conditions of the policy
- **B50.** Sum Assured on death: (Death Sum Assured) Absolute amount which is guaranteed to become payable on death of the life assured in accordance with the terms & conditions of the policy
- **B51.** Sum Assured on Maturity: (Guaranteed Maturity Sum Assured) an absolute amount of benefit which is guaranteed to become payable on maturity of the policy in accordance with the terms and conditions of the policy
- **B52.** Surrender: Option exercised by the policy holder for complete withdrawal/termination of the entire policy.
- **B53.** Surrender Value: An amount if any, that becomes payable in case of surrender in accordance with the terms and conditions of the policy.
- **B54. Underwriting:** Underwritings the process based on which, a decision on acceptance or rejection of proposal as well as applicability of suitable premium or modified terms, if any, is taken.
- **B55. UIN:** UIN means the Unique Identification Number allotted to this plan by the IRDAI
- **B56. We, Us, Our, Insurer or The Company:** Shriram Life Insurance Co. Ltd.
- **B57.** You, or Your: The Policyholder as mentioned in the Policy Schedule. The Policyholder may or may not be the life Assured.

"Death Sum Assured" is defined as highest of

- Absolute amount assured to be paid on death
- 10 times the annualised premium
- 105% of All Premiums Paid till the time of death
- Guaranteed Maturity Sum Assured

Where

"Absolute amount assured to be paid on death" is the 'Sum Assured' which is chosen by the policyholder at the time of proposal.



'Annualised premium' means the premium payable in a year chosen by the policyholder excluding underwriting extra premiums, rider premiums and loadings for modal premiums, if any.

'All Premiums Paid' is the total of all premiums paid till the date of death excluding any extra premiums, any rider premiums, revival and taxes.

"Guaranteed Maturity Sum Assured" is the 'Sum Assured' which is chosen by the policyholder at the time of proposal.

C2. Benefits under the Plan

Death Benefit

In case of death of the life assured during the policy term, "Death Sum Assured" along with the accrued bonus, (if any), and terminal bonus, if any, will be paid in lump sum to the nominee(s) or beneficiary (ies).

In case of Income Plus Lumpsum option, Income benefits that have already been paid shall not be deducted from the death proceeds.

Maturity Benefit:

Lump sum Option:

In case of survival of the life assured till the end of the policy term provided the policy is in force, "Guaranteed Maturity Sum Assured" along with the accrued bonus,(if any), and terminal bonus (if any) will be paid provided all due premiums have been paid.

Income Plus Lump sum Option:

The income benefit equal to 10% of the sum assured shall be paid annually at the end of each of the last five policy years provided the policy is force.

In case of survival of the life assured till the end of the policy term, the lump sum benefit equal to 50% of the "Guaranteed Maturity Sum Assured" along with the accrued bonus, (if any), and terminal bonus (if any) shall be paid provided all due premiums have been paid provided all due premiums have been paid.

Extended Cover Benefit:

In case the policyholder opts extended cover benefit at the time of proposal, the following additional benefits are payable during the extended cover term which starts from end of the policy term till the life assured attains the age of 80 years.

- Death Benefit: In case of death of the life assured during the extended cover term, "Sum Assured" will be paid in lump sum to the nominee(s) or beneficiary (ies).
- Survival Benefit: In case the Life Assured survives till he attains age of 80 years, the "Sum assured" will be paid to the Life Assured.

C3. Minor Lives

The life assured whose age is less than 18 years (age last birthday) at date of commencement of policy shall be considered as minors. In case of minor life assured, the risk cover starts from the 1st policy anniversary. In case of death of the minor life assured during the first policy year, the premium paid will be refunded.



The policy will be vested in the name of the Minor life assured on the policy anniversary immediately following his/her completion of 18 years of age.

C4. Riders

If the policyholder opts any rider along with this policy, please refer rider endorsement attached herewith.

C5. Payment of Premiums:

The premiums can be paid in the following premium payment frequencies.

- Yearly
- Half Yearly
- Quarterly
- Monthly

Where premium is paid in other than yearly mode, the annual premium will be multiplied by the modal factor as shown in the table below:

Annual premium rates per 1000 SA are enclosed in Annexure III.

For high sum assured policies, a premium discount as follows is applicable.

Sum Assured Band (in Rs.)	Premium Discount
Up to 3,99,999	Nil
4,00,000 to 6,99,999	2%
7,00,000 to 9,99,999	3%
10,00,000 and above	4%

C6. Grace Period and lapse:

A grace period of 30 days is allowed for payment of due premium for non-monthly modes and 15 days for monthly mode. If the death of the life assured occurs within the grace period but before the payment of premium then due, the life cover will be available and the death benefit shall be paid after deducting the said unpaid premium.

If the premium remains unpaid at the expiry of the Grace Period, the policy will lapse provided the policy doesn't acquire the paid up value. If the policy has acquired the paid up value (i.e. if at least premiums for two years have been paid), the policy will not lapse but will continue with the reduced paid up benefits.



C7. Paid up Value:

If the premium due remains unpaid at the expiry of grace period after the first two years' premium have been paid, the policy will not lapse but will continue as a reduced paid up policy.

Paid up benefits: If the policy becomes paid up, the following benefits are payable.

A) **During Policy Term**

1. Death Benefit:

In case of the death of the life assured, provided the policy is paid up, "Paid up Death Sum Assured" along with the accrued bonus,(if any), will be paid to the nominee(s) or beneficiary (ies)

Where Paid up Death Sum Assured = (Total premiums paid/Total premiums payable) x Death Sum Assured

Under the "Income plus and Lump sum option", in case of death of the life assured during the last five years under paid up policy, the Paid up Death Sum Assured shall be paid. Income benefits that have already been paid shall not be deducted from the death proceeds.

2. Maturity Benefit:

Lump sum Option:

In case of survival of the life assured up to the end of the policy term, provided the policy is paid up, "Paid up Guaranteed Maturity Sum Assured" along with the accrued bonus*,(if any), till the date of paid up and terminal bonus, if any, will be paid on the date of maturity.

Income plus Lump sum option:

If case of survival of the life assured up to the commencement of income benefits, 10% of the "Paid up Guaranteed Maturity Sum Assured" will be paid annually on the due dates as applicable for in force policy i.e. at the end of each of the last five policy years.

In case of survival of the life assured up to the end of the policy term, provided the policy is paid up, 50% of the "Paid up Guaranteed Maturity Sum Assured" along with the accrued bonus*,(if any), till the date of paid up and terminal bonus, if any, will be paid on the date of maturity.

Paid up Guaranteed Maturity Sum Assured= (Total premiums paid/ Total premiums payable) x Guaranteed Maturity Sum Assured

*Bonus (if any) will be accrued while the policy is Inforce. No further bonus will be accrued once the policy becomes paid up.

B) For policies with extended cover benefit:

If the policy with extended cover benefit becomes reduced paid up, the following additional benefits shall be paid during extended cover term.

Death Benefit: If the life assured dies during the extended cover period, paid up sum assured shall be paid to the nominee(s) or beneficiary (ies) as applicable.

Survival Benefit: If the life assured survives to the date on which he/she attains the age of 80 years, paid up sum assured will be paid to the life assured.

Paid up Sum Assured= (Total premiums paid/ Total premiums payable) x Sum Assured



PART D: Non-forfeiture Benefits & Policy Servicing

D1. Surrendering your policy:

a. Guaranteed surrender value(GSV):

The policy acquires surrender value provided premiums for at least two full years have been paid. The Guaranteed Surrender Value as a percentage of total premiums paid (excluding underwriting extra premium and GST) and accrued bonus is available under this policy as per Annexure IV. The underwriting extra premium and GST will be collected separately over and above the premium under the product.

Income Benefits paid till the date of surrender will be recovered from the Guaranteed Surrender Value (GSV).

b. Special Surrender Value (SSV):

The policies will be eligible for Special Surrender Value on payment of premiums for at least two full years. The Special Surrender Value will depend on actual experience and prevailing and expected economic conditions.

However the company will pay the higher of GSV or SSV as surrender value. No fee will be charged towards processing of surrenders.

The SSV factors will be changed only after prior approval of IRDAI.

The company do not allow surrender of extended cover benefit independently.

D2. Revivals:

A lapsed policy can be revived with in a revival period of five years from the date of first unpaid premium as per Board approved underwriting policy by paying all outstanding premiums (from date of first unpaid premium to date of revival) together with interest at a rate equal to 8% p.a., upon being satisfied as to the continued insurability of the insured on the basis of the information, documents and reports furnished by the policyholder, in accordance with the then existing underwriting policy approved by the company's Board.

The revival interest rate shall be changed in future only after prior approval from IRDAI.

D3. Loans:

Lump sum Option

The maximum loan allowable is 80% of surrender value.

The interest on loan shall be paid by the policyholder on half yearly basis. The loan interest rate is 9% p.a. compounding half yearly.

Repayment of loan: Any outstanding loan with accrued interest will be recovered from policy proceeds before any benefit is paid on the policy.

Income Plus and Lump sum option:

During the premium paying term, the maximum loan allowed is 80% of the surrender value.

If loan is availed after premium paying term, the maximum loan allowed is 60% of the surrender value.



The interest on loan shall be paid by the policyholder on half yearly basis. The loan interest rate is 9% p.a. compounding half yearly.

Repayment of loan: If there is default in the interest payment on loan or repayment of outstanding loan amount, then income benefits due or any other amount payable under the policy shall be adjusted against the outstanding loan interest and outstanding loan amount.

The company ensures that there will be no discrimination in determining the loan amount amongst the policy holders. The Company will ensure that no in force/ paid up policy will be cancelled due to non-repayment of loans. The loan interest rate currently is fixed at 9% p.a. compounding half yearly. Any change in loan interest rate will be done only after the prior approval of the Authority.

D4. Policy changes/Alterations:

Alteration of Premium Payment frequency is allowed under this plan.

No other alterations are allowed after commencement of policy.

D5. Free Look Period:

The policy holder has a period of 15 days from the date of receipt of the policy document to review the terms and conditions of the policy and where the insured disagrees to any of those terms or conditions, he has the option to return the policy stating the reasons for his objection, when he shall be entitled to a refund of the premium paid, subject only to a deduction of a proportionate risk premium for the period on cover and the expenses incurred by the Company on medical examination, if any and stamp duty charges.

A request received by the Company for free look cancellation of the policy shall be processed and premium shall be refunded within 15 days of receipt of the request

For any delay, the Company shall pay penal interest at a rate, which is 2% above bank rate from the date of request or last necessary document if any whichever is later, from the insured/claimant as stated above.

D6. Bonus Additions

- 1. Bonuses will be allocated through the simple reversionary bonus method by distribution of the surplus. The simple reversionary bonuses (as a % of sum assured) shall be declared every year after conducting valuation exercise. Once the bonus is declared, it will be added to the sum assured and guaranteed to become payable either on death or maturity. The future bonuses are attached to the policy, provided that the Policy is in-force on the date the bonus becomes due and is not a Lapsed Policy or in Reduced Paid-Up Mode.
- 2. The simple reversionary bonus rates are guaranteed to be at least 4% of the sum assured for first five years of the policy. No additional guarantee shall be applicable to the declaration of reversionary bonus from 6th year onwards. The reversionary bonuses from 6th policy year may vary depending on the experience of the participating fund with respect to mortality, lapses, investment return and expenses.
- 3. Where applicable, an interim bonus may be payable on a death/maturity claim. Additionally, at the discretion of the Company and based on experience, terminal bonus may be declared at the end of the Policy term
- 4. The policy will not accrue any bonus after the end of the policy term and during extended cover term.

F2. Correct age disclosure is important - Proof of age:

The premium has been calculated based on life assureds' age declared at the time of proposal. Age is most important criteria for calculating premium. If, at any time (including at claim stage) age is found to be different from what is stated in proposal form then following would be applicable:

If the age is proved to be higher than the age declared in the proposal, the premium will be revised based on the correct age effective from the date of commencement provided the age is within the age band eligible under this plan. Total difference amount between the revised premium and original premium with interest rate @ 8% p.a. will be collected from policyholder or deducted from the claim amount whichever is applicable.

If the age is proved to be lower than declared in the proposal, the premium under the policy will be revised effective from the date of commencement. The difference between the revised premium and the original premium will be refunded to the policyholder without interest.

However, if the correct age at entry is such that the policy cannot be offered or would have made the life assured ineligible, the policy contract will be terminated immediately by paying the surrender value, if any, subject to the section 45 of the Insurance Act 1938 as amended from time to time.

F3. Suicide Exclusion:

In case of death due to suicide within 12 months from the date of commencement of risk under the policy or from the date of revival of the policy, as applicable, the nominee or beneficiary of the policy-holder shall be entitled to 80% of the total premiums paid till the date of death or the surrender value available as on the date of death whichever is higher, provided the policy is in force.

F4. Termination of the policy:

The policy will be terminated on

- i. Payment of surrender value in case of surrender,
- ii. Payment of death benefit,
- iii. Payment of maturity benefit at the end of policy term, if extended cover benefit option is not opted.
- iv. Attaining age of 80 years if the extended cover benefit option is opted or on earlier death.
- v. Expiry of the revival period of five years, if the policy is not revived
- vi. Free Look Cancellation

F5. Nomination under the Policy:



Nominee is the person who can receive the Death benefit. It is insisted that nomination should be made in proposal from as per Section 39 of The Insurance Act, 1938 as amended from time to time. If the nomination has not been made in the proposal form, it is advised to do so at the earliest.

F7. Issuance of duplicate Policy:

In case of loss of the policy document, an indemnity bond duly notarized must be submitted. A processing fee of Rs. 100 and stamp duty of Rs. 0.20 per thousand sum assured will be payable by the policy holder.

F8. Currency:

All monies payable under the Policy to or by the Insurer shall be payable in Indian Rupees only.

F9. Documents required for making a death claim:

- a) Original policy document
- b) Proof of death/ Death certificate
- c) Identity proof of Nominee
- d) NEFT mandate form
- e) Any other document depending on the cause of death and nature of claim

F11. Delay in claim intimation:

Please communicate to us about the claim within 90 days. However if there is any delay in claim intimation due to reasons that are beyond the control of claimant then the claim would be considered.

F12. Timelines and Delay in settlement of claims:

The following are the timelines stipulated for settlement of claims/requests as per the Board approved policy for Protection of Interests of Policy holders:

i. The death claims will be paid or rejected or repudiated giving relevant reasons, within 30 days from the date of receipt of all relevant papers and required clarifications. However where the circumstances of a claim warrant an investigation in the opinion of the insurer, it shall initiate the same at the earliest and complete the such investigation expeditiously, in any case not later than 90 days from the date of receipt of claim intimation and the claim shall be settled within 30 days thereafter

If there is any delay on the part of the Company for the timelines mentioned in (i) above , the Company shall pay interest at a rate, which is 2% above bank rate from the date of receipt of last necessary document.

- ii. In respect of maturity, survival benefits and annuities, the payments will be made on or before the due date.
- iii. In respect of free look cancellation, surrender, withdrawal, request for refund of proposal deposit, refund of outstanding proposal deposit, the payments will be paid within 15 days of receipt of request or last necessary document failing which the Company shall pay penal interest at a rate, which is 2% above Bank rate from the date of request or receipt of last necessary document if any whichever is later, from the insured/claimant

F13. Taxes (GST)

Premiums are exclusive of taxes.

All Premiums are subject to applicable taxes, cesses and levies which shall be paid by you along with the Premium. If any additional Taxes /Cesses /Levies are imposed by any statutory or administrative body of this country under this Policy, the Company reserves the right to claim the same from policyholder".

F14. Fraud or misrepresentation:

In case of fraud or misrepresentation, action shall be initiated in accordance with Section 45 of the Insurance Act, 1938 as amended from time to time.



F15. Section 45 of the insurance Act, 1938as amended from time to time

- (1) No policy of life insurance shall be called in question on any ground whatsoever after the expiry of three years from the date of the policy, i.e. from the date of issuance of the policy or the date of commencement of risk or the date of revival of the policy or the date of the rider to the policy, whichever is later.
- (2) A policy of life insurance may be called in question at any time within three years from the date of issuance of the policy or the date of commencement of risk or the date of revival of the policy or the date of the rider to the policy, whichever is later, on the ground of fraud.

Provided that the insurer shall have to communicate in writing to the insured or the legal representatives or nominees or assignees of the insured the grounds and materials on which such decision is based.

(3) Notwithstanding anything contained in sub-section (2), no insurer shall repudiate a life insurance policy on the ground of fraud if the insured can prove that the mis-statement of or suppression of a material fact was true to the best of his knowledge and belief or that there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of a material fact are within the knowledge of the insurer:

Provided that in case of fraud, the onus of disproving lies upon the beneficiaries, in case the policy holder is not alive

(4) A policy of life insurance may be called in question at any time within three years from the date of issuance of the policy or the date of commencement of risk or the date of revival of the policy or the date of the rider to the policy, whichever is later, on the ground that any statement of or suppression of a fact material to the expectancy of the life of the insured was incorrectly made in the proposal or other document on the basis of which the policy was issued or revived or rider issued:

Provided that the insurer shall have to communicate in writing to the insured or the legal representatives or nominees or assignees of the insured the grounds and materials on which such decision to repudiate the policy of life insurance is based:

Provided further that in case of repudiation of the policy on the ground of misstatement or suppression of a material fact, and not on the ground of fraud, the premiums collected on the policy till the date of repudiation shall be paid to the insured or the legal representatives or nominees or assignees of the insured within a period of ninety days from the date of such repudiation.

(5) Nothing in this section shall prevent the insurer from calling for proof of age at any time if he is entitled to do so, and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof that the age of the life insured was incorrectly stated in the proposal.

Annexure II

Simplified version of provisions of Section 38 &39 of Insurance Act 1938 as amended from time to time

A. Section 38 - Assignment and Transfer of Insurance Policies as amended from time to time

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

- 1. This policy may be transferred/assigned, wholly or in part, with or without consideration.
- 2. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
- 3. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
- 4. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
- 5. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
- 6. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
- 7. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
- 8. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
- 9. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
 - a. not bonafide or
 - b. not in the interest of the policyholder or
 - c. not in public interest or
 - d. is for the purpose of trading of the insurance policy.
- 10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.
- 11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
- 12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
- 13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
 - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
 - b. where the transfer or assignment is made upon condition that



- i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
- ii. the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

- 14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
 - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
 - b. may institute any proceedings in relation to the policy
 - c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
- 15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Ordinance, 2014 shall not be affected by this section.

B. Section 39 - Nomination by policyholder

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

- 1. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
- 2. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
- 3. Nomination can be made at any time before the maturity of the policy.
- 4. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
- 5. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
- 6. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
- 7. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
- 8. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.
- 9. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or

against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.

- 10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
- 11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
- 12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
- 13. Where the policyholder whose life is insured nominates his
 - a. parents or
 - b. spouse or
 - c. children or
 - d. spouse and children
 - e. or any of them

the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.

- 14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
- 15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Act as amended from time to time.
- 16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
- 17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children 46 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.




